



## Clearfield City Neighborhood Clean-Up Program & Agreement

In addition to automated garbage collection, Clearfield City offers its residents the Neighborhood Dumpster Clean-Up program. Clearfield City residents, volunteer groups, neighborhood associations or other citizen groups may schedule delivery and pick-up of a roll-off dumpster for their neighborhood clean-up projects. The City, through Waste Management, will provide 30-yard, roll-off dumpsters to eligible participants.

***The City requires a one-time, up-front payment of \$134 for this service.***

Clearfield City residents may contact the Utility Division at 801-525-2701 to make all arrangements.

### ***RULES and REGULATIONS:***

- Dumpsters are for residential use only. A minimum of three (3) residents in the same neighborhood must sign-up for the service. The resident who contracts with the City for this service is required to provide the name, address, and phone number of at least two additional residents who will be participating in the neighborhood clean-up.
- Businesses or commercial contractors are prohibited from using this service. Violators will be cited and charged a minimum service fee of at least \$250.
- The program is NOT for home remodeling, demolition, or construction projects. Residents who require a dumpster for these types of projects must acquire a dumpster at his/her own expense. If a resident is found in violation of this provision, the resident may be charged the full cost of obtaining, delivering, and dumping the contents of the dumpster.
- NO radioactive, volatile, highly flammable, explosive, biomedical, toxic, or hazardous material (pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, tires, batteries, etc.) may be deposited in these dumpsters. Disposal of such hazardous waste is regulated by law and any attempt to illegally dispose of such will be fully prosecuted. Information on disposal of household hazardous waste may be obtained from the Davis County Health Department at 525-5000.
- NO leftover food items, food by-products, or food waste of any type may be deposited in the dumpster. NO animal carcasses or animal by-products may be deposited in the dumpster.

- **DUMPSTERS CANNOT BE OVERLOADED.** If dirt and rock materials are deposited, the dumpster can only be filled one-third full. Never fill dumpsters above the sidewalls. Residents using the dumpsters will be required to clean up any spillage caused by overloading. If materials are deposited over the weight limit or on the ground, a fee may be assessed.
- Dumpsters may only be used for a maximum of seven calendar days.
- A responsible adult from the requesting organization must monitor the dumpster to ensure compliance with all rules and regulations.
- Waste Management, Clearfield City, their officers, agents, and employees are hereby released from any, and all liability for damages resulting from equipment or personnel being on private property to deliver or remove the dumpsters and from any injuries incurred by individuals using or coming into contact, with the dumpsters.
