**ADVERTISEMENT FOR BIDS FOR BIRCH STREET RECONSTRUCTION (#239)**

Sealed Bids for the construction of the **BIRCH STREET RECONSTRUCTION (#239)** will be received electronically by **Clearfield City, through Bonfire** before the bid opening date and time. Prior to submitting a bid, the contractor must register as a vendor on Bonfire. Clearfield City is not responsible for vendor accounts or access to Bonfire. The Bidder is encouraged to allow sufficient time for the process when submitting bids.

A public bid opening will be conducted but attending in person will not be possible. Bids will be received until 2:00 PM local time on June 11, 2026, at which time the Bids received will be publicly opened and read aloud via a live video stream to all participants. The Project consists of the reconstruction of Birch Street, 350 South and Birch Circle. The project will also include utility work (e.g. storm, sanitary sewer, water and irrigation), including work in 750 East. The project has an Engineer's Estimate of \$2,536,895.00.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, as indicated in the Bid Form. All documents listed in paragraph 7.01 of the Bid Form must be submitted.
